What to Expect with our Bridal Salon Services

Initial Consultation:

This is usually done over the phone, and can also be handled via email, or face to face by appointment. We will discuss your hair and make-up needs then schedule your trial and wedding day services based on your photo and ceremony times. We offer bridal salon services everyday, including Sundays. We also provide on-site service at your location for a travel fee.

Hair and Make-up Trials:

The cost of any trial services does not apply toward any wedding day costs. It does, however, give you a sense of knowing everything will be just the way you envisioned it. A trial is highly recommended, if possible. We have found the trial not only puts the bride at ease, but also makes time run much smoother on the wedding day. It also allows us to account for what your hair will do in respect to the style you have chosen. If adjustments are needed, we can make them ahead of time. Hair and Make-up trials are best booked as 1 appointment anytime from several months, to just a few days prior to your wedding.

Please bring all accessories you will be wearing on your wedding day, such as your veil, hair clips, jewelry, etc. Arrive with clean, dry hair and a freshly washed, lightly moisturized face. If you have any favorite make-up items feel free to bring them and know that we stock a full selection of professional-grade hair and makeup products.

Wedding Day Hair and Make-up:

We will recreate the look we achieved during your trial or in the pictures you provide. Please bring all accessories with you. Please note that our bridal hair services are up-do's and hot styles. We do not cut or color hair the day of a party, and we ask that you arrive with clean, dry hair and wear a top that does not need to be removed over hair or face. We do not shampoo or blow-dry hair unless it is an added service. If anyone has pictures of the style they would like to have done, please bring them with you. Pictures greatly improve communication with the stylists. For anyone having make-up services please arrive with a freshly washed lightly moisturized face. Please make sure all moisturizer is SPF free as the SPF can interfere with photography.

Additional Spa & Wellness Services

If you are interested in spa services before your wedding day such as massages, nails, facials or a private yoga class for your bridesmaids, groomsmen, or parents, please let me know so we can check availability and create custom packages.

Securing Appointment Date:

Peak season and weekend dates are in high demand; we recommend you book your wedding services at least 4-6 months in advance. Your appointment dates and services will be fully secured once we have received the signed bridal agreement and the non-refundable deposit (\$100 for parties of 3 or less, \$150 for parties of 4 or more), which is credited toward your bridal salon services the day of your wedding. We also require a credit card on file to secure your date. See further details on our Service Agreement.

Frequently Asked Questions

HOW FAR IN ADVANCED SHOULD I BOOK MY BRIDAL SALON SERVICES?

We book months in advance, sometimes even a full year. So it's best to secure your date as soon as you can! You can start the process by filling out our online wedding form.

SHOULD I WAIT TO BOOK IF I DON'T KNOW HOW MANY PEOPLE IN MY PARTY WILL ACTUALLY DO SERVICES?

We suggest you reserve your date now with a deposit. Please make sure you understand our cancellation policy. We are as flexible as we can be, especially when there is plenty of lead time.

HELP! MY WEDDING IS IN LESS THAN A MONTH. CAN YOU STILL DO MY HAIR AND MAKEUP?

Sometimes we do have last minute availability. We will help if we can. Complete the online form right away!

WHAT IS AIRBRUSH FOUNDATION AND WHY DOES IT COST MORE?

Airbrush foundation can be requested in place of regular foundation. It is lightweight and applied through an airbrush gun that produces a thin, even layer of makeup to create a flawless matte finish. The fine mist will allow your natural skin tone to show through, making it look more natural and less caked on. Airbrush foundation is waterproof (tears, anyone?), long lasting and will not transfer on to clothing – It looks amazing in professional photographs! There is an upcharge for this deluxe makeup application due to equipment and supply costs plus extra cleanup time for our stylists.

WHAT BRANDS OF MAKEUP AND HAIR PRODUCTS DO YOU USE?

All of the hair and makeup products that we use are tried and true professional grade, designed to give long-lasting, photo-friendly results.

SHOULD I ADD FALSE EYELASHES?

We have a selection of professional grade lashes from natural to glamorous and will apply them expertly and quickly. If you prefer to supply your own lashes for us to apply during your makeup session there is still an application fee. Lashes are our most popular same day add-on.

CAN YOU COME TO MY LOCATION?

Of course! We want things to be comfortable and convenient for you. A \$15 travel fee is applied to each client receiving services within 10 miles from Body & Sol. Longer distances are negotiable and may incur a higher travel fee. Keep in mind that travel services incur more time for our Stylists to load and unload gear, so please don't ask us to waive this fee for their time.

ABOUT HOW LONG DOES IT TAKE YOU TO DO EACH SERVICE?

Makeup appointments typically take 25-30 minutes, hair appointments take 30-45 minutes. Additional services will add extra time (lashes, long/thick hair, hair extension application, accessories, etc.). These are approximate times, and additional time may still need to be added into wedding day timelines.

WHEN SHOULD I HAVE MY TRIAL?

This usually comes down to what your schedule permits, and how eager you are to see your hair and/or makeup in advance. We do trials several months out as well as just a few days out. Keep in mind, it is best to do the trial once you know the neckline of your dress.

DO I WASH MY HAIR THE MORNING OF THE TRIAL/WEDDING?

There seems to be a misconception actually, that you shouldn't have clean hair if you're having it put up. Arrive with it washed the night/day before (if you have very oily hair wash and dry the morning of.) We suggest you come with it dried and in desired part.

WILL THE STYLIST WHO DOES MY TRIAL BE THE SAME ON MY WEDDING DAY?

Yes, unless there are unforeseen circumstances that prevent the Stylist from being able to be at your wedding day appointment, or you request a different Stylist. In that scenario, all images and communications from the trial run will be relayed to the wedding Stylist.

IS THERE A DISCOUNT FOR MY FLOWER GIRL?

Yes! We offer special rates for Flower Girls (aged 10 and under) as well as Jr. Bridesmaids (aged 11 -15).

WHAT IF I WANT TO GET MY NAILS DONE, TOO?

As a full service day spa we offer natural nails (no acrylics, or tips) including long-lasting shellac. Depending on your timeline and the size of your party, we suggest doing nails the day before the Big Day.

DO YOU HAVE ANY SPECIAL PACKAGES FOR A SPA DAY IF WE BOOK THE BRIDAL SERVICES WITH YOU?

We'd love to help you and your special group relax for the Big Day either at Body & Sol or on-site. We've got lots of options, from chair massage at your pool, to a Shower or Bachelorette Spa Party. Please contact our spa group coordinator, Amanda, at 941-896-2222.

CAN WE GET DRESSED THERE?

Sure! We need to know this in advance so that we can properly store your dresses, etc.

CAN WE HAVE THE PHOTOGRAPHER COME IN WHILE WE ARE GETTING READY?

Of course!

WE ARE DOING PHOTOS EARLY - WILL MY HAIR AND MAKEUP LAST UNTIL THE CEREMONY?

Definitely! This is why you are paying professionals.

WE NEED TO EAT BEFORE THE CEREMONY. CAN WE BRING OUR OWN FOOD AND DRINKS TO HAIR AND MAKEUP TIME?

Absolutely! We even have wine glasses and a fridge. If you prefer delivery or takeout, we are happy to make suggestions.

WHAT IS YOUR CANCELLATION POLICY?

A deposit (\$100 for parties of 3 or less, \$150 for parties of 4 or more) is required to save the date. Payment for all services are due the day of service. Any services not paid in full on the wedding day will be charged to the credit card on file.

Cancellations without 14 days notice will be charged a cancellation fee to the credit card associated with this bridal agreement as follows: less than two weeks (14 days) prior to your appointment, your credit card will be charged for 50% of the cost of services, less than 48 Hours (2 days), your credit card will be charged for 100% of the cost of service. Please keep in mind that should any party member forego a prearranged service on date of service, 100% of the charge will apply.

A 20% service fee will be added to all services. We can travel to your location on Anna Maria Island for an additional travel charge of \$15 for each guest receiving services. Travel to other areas is negotiable.

Bridal Salon Service Agreement

Thank you for choosing Body & Sol for your special day!

Deposit: Your deposit is required to reserve the date above. Deposit will be applied to wedding day services. An invoice for the deposit (\$100 for parties of 3 or less, \$150 for parties of 4 or more) will be sent to you via email, for online payment. **When paying that invoice, be sure to check the option to save the card details for future invoices and purchases.** If this option IS NOT selected when paying the initial invoice, the last page of this packet will need to be printed and returned with the agreement. Your credit card will not be charged until the day of service, except in accordance with our cancellation policy.

Payment: Payment for all services are due the day of service. Individual or group payments in cash or by credit card are accepted. Additional fees may be incurred for adding extra services or clients as well as for thick or long hair. Any services not paid in full on the wedding day will be charged to the credit card on file.

Bridal Party Appointment Bookings, Changes and Cancellations: The Bride will complete the Online Bridal Party Detail Form on our website (<https://annamariadayspa.com/bridal-party-detail-form/>), to provide a realistic estimate of the specific services and number of guests to schedule. To ensure proper Stylist and facilities staffing for your party, kindly make any service changes, cancellations or additions as soon as possible via the Body & Sol Bridal Coordinator Chelsea via email at bodyandsol.brides@yahoo.com.

Cancellations not made with at least 14 days notice will be charged a cancellation fee to the credit card associated with this bridal agreement as follows: In the event any service is canceled less than two weeks (14 days) prior to your appointment, your credit card will be charged for 50% of the cost of services. If any cancellations are made within 48 Hours (2 days) or less, your credit card will be charged for 100% of the cost of service. Please keep in mind that should any party member forego a prearranged service on date of service, 100% of the charge will apply.

Gratuity: An additional 20% service fee will be added to all services. This is designed to make it easier for you and your party as they may see multiple stylists on the day of the services. The gratuities are distributed accordingly to your service providers.

Travel and On Site Services: We do offer travel to your location on Anna Maria Island for an additional travel charge of \$15 for each guest receiving services. Travel to other areas is negotiable.

Responsible Party: I have read, understand and agree to the terms of this bridal agreement. Reservations for services(s) will be secured once the signed bridal agreement, deposit and credit card guarantee are received.
